1a. Description of request:

Construction of a Regional Operations and Maintenance Facility at Hovander Homestead Park to support the Department's West region has been a Departmental priority since 2010 at which point design drawings were developed but not advanced to construction. Since that time, project plans and specifications have been updated to meet current departmental needs, and are being revised comply with building codes and regulatory requirements. Regulatory approval of the project plans is anticipated by the Fall of 2026. Current project funding, in the amount of \$1,696,378 was approved under Ordinance# 2024-068 -AB2024-749, and is a part of the approved 2025 Capital Improvements Project List (ORD# 2024 -058).

In response to current capital acquisition initiatives, and in collaboration with the Executive's Office, this request removes \$1,200,000.00 of funding allocated for construction from the Operations and Maintenance Facility budget. The intent of the adjustment is to address a near-term need to achieve targeted acquisition priorities. And, it is with mutual understanding that these near-term pressures on fund balances will be somewhat alleviated by the year 2027, when capital funding sufficient to construct the complete scope of Operations and Maintenance Facility will be reallocated to the project budget.

1b. Primary customers:

Whatcom County Residents, visitors of Whatcom County, and Whatcom County Park Maintenance and Operations staff are the primary beneficiaries of this effort.

2. Problem to be solved:

Near-term pressures on capital funding are at levels that reallocation of existing but unspent funding realizes short-term gains to facilitate high-priority acquisitions. The temporary reallocation of this dedicated funding won't necessarily negatively impact progress of the Operations and Maintenance Facility project because PARKS anticipates advancing the project through final design, engineering, and permit approval over the next 10 to 12 months. Therefore, targeting construction to begin in 2027 when funding is reallocated will maintain approximately the project's current schedule.

3a. Options / Advantages:

In the short-term, this strategy will allow securing strategic acquisitions to facilitate county operations, while maintaining the high-priority departmental initiatives.

4a. Outcomes:

Outcomes of this effort will maintain acceptable capital funding balances, while advancing Operations and Maintenance Facility to a "shovel-ready" project status. Once funding has been reauthorized, PARKS anticipates beginning construction in early Spring 2027.
