**ORDINANCE NO. 2025-008**

**CLOSING SHALLOW SHORE CULVERT RELOCATION FUND 3917**

**WHEREAS**, on November 24<sup>th</sup>, 2020, Ordinance 2020-071 created the Shallow Shore Culvert Relocation Fund and funded the project; and,

**WHEREAS**, the project has now been completed; and,

**WHEREAS**, the project fund is no longer needed; and,

**WHEREAS**, the Real Estate Excise Tax II Fund contributed funds towards the project; and,

**WHEREAS**, the current cash balance in the fund is \$172,283.99; and,

**WHEREAS**, remaining cash in the fund should be returned to the Real Estate Excise Tax II Fund,

**NOW, THEREFORE, BE IT ORDAINED** by the Whatcom County Council that the Shallow Shore Culvert Relocation Fund be dissolved and its remaining cash balance be returned to the Real Estate Excise Tax II Fund .
