**WHATCOM COUNTY COUNCIL UPDATING TO THE APPENDIX OF THE 2022  
COMPREHENSIVE ECONOMIC DEVELOPMENT STRATEGY (CEDS)**

**WHEREAS**, the Economic Development Reform Act of 1998 identifies a Comprehensive Economic Development Strategy (CEDS) as a requirement to apply for assistance under the Economic Development Administration's (EDA) economic adjustment and public works program; and

**WHEREAS**, Public Law I 05-393, implemented in 1999, amends the Public Works and Economic Development Act of 1965 and re-authorizes Economic Development Administration Programs for five years; and

**WHEREAS**, in 2021, the Port of Bellingham, through an interlocal agreement with the county, completed the work to update the document which Council approved through Resolution 2021-046; and

**WHEREAS**, the Port of Bellingham worked with each of the municipalities to update the list to ensure new projects were added and completed projects were removed; and

**WHEREAS**, the revised project list is included in Attachment "A", titled Updated CEDS 2026 Project List; and

**WHEREAS**, RCW 82.14.370 requires that projects utilizing rural sales tax revenue must be contained in the County's overall economic development plan.

**NOW, THEREFORE, BE IT RESOLVED** by the Whatcom County Council that that the Whatcom County Council hereby accepts the updated appendix as submitted by the Port of Bellingham; and

**BE IT FINALLY RESOLVED** by the Whatcom County Council that that the Whatcom County Council officially adopts this 2026 update to the 2022 Whatcom County Economic Development Strategy Appendix.
