The Whatcom County Council will have a public hearing, consider adopting, and may amend the following at its September 24, 2019, meeting, or at a later date:

**ORDINANCE GRANTING COMCAST COMMUNICATIONS MANAGEMENT, LLC, A NON-EXCLUSIVE FRANCHISE FOR THE PROVISION OF CABLE SERVICES WITHIN THE UNINCORPORATED AREAS OF WHATCOM COUNTY (AB2019-366):**

This ordinance grants a non-exclusive franchise to Comcast Cable Communications Management, LLC, for a period of ten (10) years in order that it may install, construct, erect, operate, maintain, repair, relocate, and remove its facilities in, on, upon, along, and/or across those rights-of-way for purposes of offering and providing cable services utilizing said facilities.

The franchise area is described as those public rights-of-way located within the present or future unincorporated limits of the County. This ordinance was introduced on July 9, 2019.

**ORDINANCE GRANTING WAVEDIVISION I, LLC, A NON-EXCLUSIVE FRANCHISE FOR THE PROVISION OF CABLE SERVICE WITHIN THE UNINCORPORATED AREAS OF WHATCOM COUNTY (AB2019-368):**

This ordinance grants a non-exclusive franchise to WaveDivision I, LLC, for a period of ten (10) years in order that it may install, construct, erect, operate, maintain, repair, relocate, and remove its facilities in, on, upon, along, and/or across those rights-of-way for purposes of offering and providing cable services utilizing said facilities.

The franchise area is described as those public rights-of-way located within the present or future unincorporated limits of the County. This ordinance was introduced on July 9, 2019.
