While multifaceted, much of my work with NPAIHB is on our Indian Country ECHO (Extensions for Community Health Outcomes) team. We were honored with the National Impact Award in 2022 by the National

community activities, and education	Indian Health Board to recognize our significant positive impact on the health of American Indian and Alaska Native communities on a national level. In addition, I serve as the Indigi-IWTK ("I Want the Kit") and Tribal STI/HIV Capacity Building Project Manager and work in collaboration with the excellent team at Johns Hopkins to continue to lower barriers in access to screening and treatment for STIs in our Tribal and rural communities.
	Prior to working at NPAIHB, I was priviledged to work for several years at the Lummi Tribal Health Center and assisted with our COVID-19 response team, led our behavioral health crisis and overdose response teams, started and managed the harm reduction program, and helped build and manage our HCV elimination program (this work was used to support and help draft the "Hep C Free Washington" guidelines created in 2018). I have presented on this work locally and internationally and am passionate about ensuring equitable health care is accessible to all. I worked for several years in health care relief work in Mozambique, Sudan, and Madagascar and have gained unique public health insights from each of these valued experiences.

I am eager to dedicate more time to engaging at the local level, working toward the best possible health outcomes for residents of Whatcom County, and continuing to advocate for historically underserved populations.
