**ORDINANCE NO. 2023 - 051**

**ESTABLISHING PARKING RESTRICTIONS ON ALDRICH ROAD  
AS WHATCOM COUNTY CODE 10.24.265**

**WHEREAS**, the Revised Code of Washington, RCW 46.61.570, authorizes the placement of official signs prohibiting stopping, standing, or parking; and

**WHEREAS**, the Whatcom County Council has heard many complaints of nuisance activities along Aldrich Road that warrant establishing a no parking area.

**NOW, THEREFORE, BE IT ORDAINED** by the Whatcom County Council that the Whatcom County Code be amended to add a new section as follows:

10.24.265 Aldrich Road

A "No Parking" zone is established on Aldrich Road on both sides of Aldrich Road from the southerly intersection of the Right-of-Way of Waldron Road to the Bellingham City Limits.

**BE IT FINALLY ORDAINED** that the County Engineer is hereby directed to install the appropriate signs and that the Whatcom County Sheriff be notified by providing a copy of this ordinance.

**ADOPTED** this 12th day of September, 2023.
