COUNCIL ACTION TAKEN

The Whatcom County Council adopted the following at its August 7, 2019, meeting: **ORDINANCE (AB2019-059) AMENDING WHATCOM COUNTY CODE CHAPTER 11.32 BOATING AND SWIMMING, SPECIAL RESTRICTION, RELATING TO TWO-STROKE ENGINE POWERED WATERCRAFT (AB2019-383):**

AB2019-383

This ordinance amends Whatcom County Code Chapter 11.32, Boating and Swimming, Special Restrictions, to prohibit the operation of all two-stroke engine-powered watercraft on Lake Samish, effective November 1, 2020, except as follows: Watercraft powered by a two-stroke-powered engine whose engine is certified and labeled as meeting the 2006 or later model year United States Environmental Protection Agency (EPA) emissions standards, as specified in Title 40, Code of Federal Regulations, Part 91. This ordinance was introduced July 9, 2019. **ORDINANCE (2019-060) AMENDING ORDINANCE 81-6 (SECOND REQUEST) TO AMEND THE PURPOSE OF THE COMMUNITY DEVELOPMENT FUND (AB2019-399):**

This ordinance amends the purpose of the Community Development Fund to include using the proceeds of repayments from the Deferred Payment Sewage System Loan Program to the On-site Sewage System Program rebates and incentives. This ordinance was introduced on July 23, 2019. **ORDINANCE (2019-061) AMENDING THE 2019 WHATCOM COUNTY BUDGET, REQUEST NO. 10, IN THE AMOUNT OF \$2,650,000 (AB2019-400):**

This ordinance appropriates \$2,650,000 from the Public Utilities Improvement Fund to fund the Blaine Gateway Regional Stormwater and Wetland Facility Project.
