and recycled complete junk cars for free. I worked at Alcoa Intalco Plant for 3 years 2010-2012. I worked as an Alcohol/Drug Assessment Officer at Whatcom County District Court's Assessment unit for a year+ in 2009-2010. I have worked refinery shutdowns in Skagit County. I worked as a State Certified Chemical Dependency Counselor, Assessment Officer, Interventionist, and Alcohol/Drug Information School Instructor for 14 years and two years as an Outpatient Treatment Agency Administrator. I also served at the former Adolescent Residential Treatment Facility, Safe Passage, in Sedro-Woolley as a Primary Counselor. I studied Human Services with emphasis on Substance Abuse and Treatment at Skagit Valley College, Business Administration at Everett Community College, and EMT training while in the Coast Guard at Portsmouth Naval Hospital. I served an elected Student Body representative in the Student Government at Everett Community College in the early 80s and was instrumental in forming and adopting a new student government model for the college on the Student Government Model Committee and as the only member who knew both the U.S.A. and Washington State Constitutions I kept the new student government model constitutionally compliant. As a result of my efforts, the new student government model passed muster with the College administration, the then Washington Attorney General's Office and the Governor's Office on the first pass. I am a board member of the Friends of the North Fork Community Library (FNFCL).

Please describe why you're interested in serving on this Advisory Group.

I have uncommon sense which is needed in this county, especially in looking for solid waste solutions. Since the glass recycling company in Seattle stopped taking recyclable glass, I see this as an opportunity for our county to apply for State and federal grants to open a glass recycling business in Whatcom County, which will take recyclable glass from our county and other counties that pay us for this service. This revenue stream may afford our county the opportunity to reduce sales and property taxes, which for example would create more car sales in our county, as most people buy cars in Skagit County, which has a lower sales tax.

I envision a transfer station and recycling center in East Whatcom County that is open Friday, Saturday, and Sunday, except for holiday weekends. I envision our county soliciting grant applications from Whatcom County residents for starting and operating a model yard waste receiving, and composting yard waste for Whatcom County residents ideally with a portion set aside for organic yard waste from property owners who refrain from using pesticides, herbicides, fungicides, and other toxic man made chemicals in, around, and on their yards, trees, etc...I assert that there is a market for organic yard waste compost for gardeners, and other property owners.
