1. <u>AB2023-332</u> Discussion relating to the draft scope of work for the 2025 Comprehensive Plan and development regulations update

Matt Aamot, Planning and Development Services Department, briefed the Councilmembers. He stated they are asking Council for an endorsement of the scope and they will attach it to a Request for Proposal (RFP) for consultant services. They would then bring a proposed consultant contract to the Council for approval at a later date.

Galloway spoke about the changes made in the revised version (Revised Draft Scope of Work for 6.20.2023).

Aamot stated they are not looking for formal action of the Council at this time, but are just looking for an informal endorsement of the revised scope. He answered whether they are talking about a contract for the people that are going to do the land capacity analysis or about a contractor to do the entire Comprehensive Plan and stated they will do more than the land capacity analysis. They will do specific tasks that are laid out in the scope of work. It will be a combination of consultant work and staff work.

Councilmembers and Aamot discussed the process for working with County staff when Councilmembers would like to see changes to the Whatcom County Code or in the Comprehensive Plan.

*Galloway moved* to support the scope of work for the 2025 Comprehensive Plan and development regulations update. The motion was seconded by Donovan.
