7. Please describe your occupation (or former occupation if retired), qualifications, professional and/or community activities, and education.

I've been a licensed residential real estate appraiser for 17 years, which involves highest-and-best-use analysis and developing opinions of value for tax, estate, mortgage, and refinance purposes. For about 10 of those years, I also sold homes, which gave me practical experience helping people assess development feasibility through analysis of zoning and building codes across District 5. I returned to full-time appraisal at the beginning of this year because I prefer the analytical side of real estate over the emotional side.

Through my personal land use applications in Whatcom County, I've worked directly with shoreline management, flood and critical areas, building codes, and the consultant/study process.

For the past three years, I have served on the Birch Bay Chamber of Commerce board and chaired the Birch Bay Incorporation Association. Additionally, I helped draft the code and resolution that created the new Birch Bay Community Advisory Committee. My work with these groups has involved regular interaction with County staff and elected officials on growth, service delivery, and representation.

Altogether, my valuation, real estate, and community volunteer work have given me a well-rounded understanding of planning in Whatcom County and how GMA policies, comprehensive planning, and local regulations affect property owners.

8. Please describe why you're interested in serving on this advisory group:

I've lived most of my life in the Birch Bay Urban Growth Area and want to make sure Birch Bay and Blaine are well represented in county planning decisions. I stay active locally through the Birch Bay Chamber of Commerce and the Birch Bay Incorporation Association/Community Advisory Committee effort, so I'm well positioned to serve as a liaison on the Planning Commission.

At the same time, my work takes me all over District 5, including Blaine, Ferndale, and communities that sometimes get overlooked like Point Roberts, Lummi Island, Sandy Point, and Custer. This work lets me see how these areas are changing over time and gives me a good sense of their needs and constraints. Because I'm rooted in Birch Bay but work across the whole district, I can help connect local concerns to county-level decisions.

Lastly, I enjoy thinking about planning and land use, and the independent nature of my work allows me the flexibility to volunteer my time to this important process.
