The Whatcom County Council will consider adopting and may amend the following at its February 23, 2021, meeting or at a later date: ORDINANCE AMENDING THE 2021 WHATCOM COUNTY BUDG-ET, REQUEST NO. 3 IN THE AMOUNT OF \$7,854,280 (AB2021-092): This ordinance amends the 2021 budget to appropriate: \$47,016 in Parks to fund Lookout Mountain Road failure A&E from grant proceeds, \$30,625 in Parks to fund Point Whitehorn Stair-Parks to tund Point Whitehorn Stailway A&E from grant proceeds, \$163,777 in Sheriff to fund Operation Stonegarden FY19 program from grant proceeds, \$2,419 in Sheriff to fund Organized Crime Drug Enforcement Task Forces program from grant proceeds, \$6,809,443 in Health to fund Ernergency Rental Assistance 2021 program from grant proceeds, \$551,000 to fund COVID response recovery activities, \$250,000 to fund City of Lynden Glenning Park project.
