The Whatcom County Council adopted the following at its July 9, 2024, meeting: RESOLUTION (2024-033) TO DECLARE WHATCOM COUNTY REAL PROPERTY AS SURPLUS AND APPROVE TRANSFER (AB2024-348): This resolution declares as surplus and approves the transfer of tax parcel number 390109 183088 0000, a 6.96-acre tract at 3970 Kickerville Lane, subject to conservation easement, to the Lummi Nation for no consideration, per recommendation by the Whatcom County Property Management Committee and pursuant to RCW 36.34.130 and Whatcom County Code 1.10.340. This resolution was introduced on June 4, 2024.

The Whatcom County Council will consider adopting and may amend the following at its 6 p.m. meeting on July 23, 2024, or at a later date: ORDINANCE SUBMITTING TO THE QUALIFIED VOTERS OF WHATCOM COUNTY A PROPOSAL TO REPEAL PROPOSITION 5 (AB2024-419): This ordinance provides for submission to the qualified electors of Whatcom County of a proposition repealing the Children's Initiative Levy Lid Lift, eliminating the 10-year increase of Proposition 2022-5 and all related legislation and implementation, including Ordinance 2022-045 and Ordinance 2022-059. This ordinance was introduced on July 9, 2024. ORDINANCE CREATING WHATCOM COUNTY CODE 2.49, ESTABLISHING THE JUSTICE PROJECT FINANCE AND FACILITY ADVISORY BOARD (AB2024-453): This ordinance establishes the Justice Project Finance and Facility Advisory Board through the creation of Whatcom County Code 2.49 and requires that future updates of the Justice Project Implementation Plan include the membership and appointment process Project Implementation Plan include the membership and appointment process of the Finance and Facility Advisory Board and its functions consistent with the interlocal agreements. This ordinance was introduced on July 9, 2024. ORDINANCE AMENDING THE PROJECT BUDGET FOR THE WAY STATION PROJECT FUND, REQUEST NO. 4 (AB2024-460): This ordinance amends the project budget for the Way Station Project Fund by appropriating \$100,000 to fund increased costs and ensure project timelines are for the temporary morgue relocation for a total project budget of \$14,137,461. This ordinance was introduced on July 9, 2024. ORDINANCE AMENDING THE 2024 WHATCOM COUNTY BUDGET, REQUEST NO. 9, IN THE AMOUNT OF \$873,134 (AB2024-463): This ordinance amends the 2024 Whatcom County budget as follows: From the General Fund: appropriate \$28,100 in Executive to fund Morgue Storage; appropriate \$190,000 in Executive to fund Office of Healthy Housing Grant; appropriate \$52,900 in Executive to fund Washington State Military Department E911 Grant; appropriate \$6,011 In Health to fund Do-It-Yourself (DIY) Air Cleaner Kits; appropriate \$100,000 in AS-Facilities to fund 5th floor courtroom remodel with grant proceeds; appropriate \$150,000 in Planning and Development Services to fund Birch Bay incorporation feasibility study. From the Road Fund: use Public Works lapse from vacant positions in 2024 with additional costs reflected in 2025 to fund Senior Planner Archeologist position. From the Veteran's Relief Fund: appropriate \$100,000 to fund veterans' relief with additional financial assistance. From the Behavioral Health Fund: appropriate \$101,896 to fund additional Jail services with grant From the American Rescue Plan Act Fund: decrease appropriation of \$2,750,000 to reallocate budget authority for childcare capital projects to the Community Priorities Fund. From the Community Priorities Fund: appropriate \$2,750,000 to fund childcare capital projects. From the Emergency Management Fund: appropriate \$29,227 from Sheriff Division of Emergency Management to fund SHSP FFY23 program with grant proceeds; appropriate \$15,000 from Sheriff Division of Emergency Management to fund DHS EMPG 2022-S program with grant proceeds. From the Public Utilities Improvement Fund: appropriate \$100,000 to fund companion to morgue relocation for Waystation project. This ordinance was introduced on July 9, 2024.
