This grant agreement with Washington Department of Ecology provides the County with \$249,000.00 for administrative and technical support to the MRC and to implement action projects. No match is required. Budget authority for 2023 is included in the approved 2023 Natural Resources budget. Budget authority for 2024 is included in the 2024 Natural Resources budget proposal to the Board of Supervisors. Budget authority for 2025 will be requested in the 2025 Natural Resources budget.

Task Title: Task 2: Monitoring

Task Description:

The RECIPIENT will conduct monitoring for bull kelp, forage fish, harmful algal bloom, and Pollution Identification and Correction (PIC) as follows:

2.1 Bull kelp monitoring: Working in collaboration with the Northwest Straits Commission and using existing monitoring protocols, the RECIPIENT will monitor floating bull kelp beds at four locations in Whatcom County to provide information on the status (presence, size, health) of floating kelp communities in Whatcom County.

The RECIPIENT will provide a copy of the addendum to the 2024 Quality Assurance Project Plan (QAPP) and a new five-year 2025 QAPP. They will also provide a workplan and final survey Report for bull kelp monitoring.

2.2 Forage fish spawning habitat monitoring: The RECIPIENT will participate in a regional effort to characterize populations of the two species of forage fish that spawn on Puget Sound beaches: Pacific sand lance and surf smelt. The RECIPIENT will serve as a local partner to the Washington Department of Fish and Wildlife (WDFW) to conduct wide scale spawning surveys and support their efforts and expand the impact of the study. The RECIPIENT will also conduct forage fish egg presence/absence analysis from beach substrate samples.

The RECIPIENT will provide a copy of the addendum to the 2024 Quality Assurance Project Plan (QAPP) and a new five-year 2025 QAPP. They will also provide a workplan and final survey report for forage fish monitoring.

2.3 Harmful algal bloom monitoring: The SoundToxins monitoring network, managed by Washington Sea Grant, monitors over three dozen sites for harmful algae blooms (HABs) throughout the Salish Sea. The RECIPIENT will lead the addition of two new sites in Whatcom County: Semiahmoo Marina and Birch Bay Marina. RECIPIENT will monitor sites for phytoplankton weekly from March-November and biweekly from November-February, and analyze samples phytoplankton concentrations, focusing on several potential HAB species.

The RECIPIENT will provide a copy of the sampling plan determined by the SoundToxins manual, and final report (data summaries and list of volunteers) for HABs monitoring.

2.4 N. Chuckanut Bay Pollution Identification and Correction: The RECIPIENT serves as a partner in a Pollution Identification and Correction (PIC) project in the Chuckanut Village area. The RECIPIENT will conduct ongoing community outreach and engagement, conduct water quality monitoring from marine and freshwater sites, complete data reporting on a monthly basis to project partners and the community.

The RECIPIENT will provide a copy of the addendum to the 2024 Quality Assurance Project Plan (QAPP) and a new five-year 2025 QAPP. They will also provide a final report (data, water quality summaries, outreach) for Bull kelp monitoring.

There are four goals for this task:

1. To provide a better understanding of kelp distribution, bed sizes, kelp speciation, and health within the Salish Sea and to cultivate community stewardship for kelp habitats.
2. To survey local beaches for forage fish that supports statewide sampling and will inform potential soft shore restoration projects for Whatcom County.
3. To fill a data gap for harmful algal bloom monitoring at sites of interest to the RECIPIENT.
4. To provide the Washington State Department of Health with sufficient data demonstrating an improvement in water quality. This will help recreational shellfish harvesting restrictions to potentially be appropriately modified, and to continue outreach and engagement within the Chuckanut Village community so water quality improvements can be maintained.

Task Expected Outcome:

Monitoring data will be incorporated into the larger database and a multi-year record of kelp distribution and trends at the monitoring sites.

Forage fish data will be gathered on forage fish spawning grounds, which result in legal protections of spawning beaches in Washington State.

- d) If any human remains are found while conducting work under this Agreement, follow the protocol outlined in the project IDP.
- Immediately stop work and notify the local Law Enforcement Agency or Medical Examiner/Coroner's Office, the Department of Archaeology and Historic Preservation at (360) 790-1633, and then the ECOLOGY Program.
- e) Comply with RCW 27.53, RCW 27.44, and RCW 68.50.645, and all other applicable local, state, and federal laws protecting Cultural Resources and human remains.

5. ASSIGNMENT

No right or claim of the RECIPIENT arising under this Agreement shall be transferred or assigned by the RECIPIENT.

6. COMMUNICATION

RECIPIENT shall make every effort to maintain effective communications with the RECIPIENT's designees, ECOLOGY, all affected local, state, or federal jurisdictions, and any interested individuals or groups.

- i) Monies withheld by ECOLOGY may be paid to the RECIPIENT when the work described herein, or a portion thereof, has been completed if, at ECOLOGY's sole discretion, such payment is reasonable and approved according to this Agreement, as appropriate, or upon completion of an audit as specified herein.

15. INDEPENDENT STATUS

The employees, volunteers, or agents of each party who are engaged in the performance of this Agreement will continue to be employees, volunteers, or agents of that party and will not for any purpose be employees, volunteers, or agents of the other party.

- b) Publications. When the RECIPIENT or persons employed by the RECIPIENT use or publish ECOLOGY information; present papers, lectures, or seminars involving information supplied by ECOLOGY; or use logos, reports, maps, or other data in printed reports, signs, brochures, pamphlets, etc., appropriate credit shall be given to ECOLOGY.
- c) Presentation and Promotional Materials. 22. RECORDS, AUDITS, AND INSPECTIONS

RECIPIENT shall maintain complete program and financial records relating to this Agreement, including any engineering documentation and field inspection reports of all construction work accomplished.

All records shall:

- a) Be kept in a manner which provides an audit trail for all expenditures.
 - b) Be kept in a common file to facilitate audits and inspections.
 - c) Clearly indicate total receipts and expenditures related to this Agreement.
 - d) Be open for audit or inspection by ECOLOGY, or by any duly authorized audit representative of the State of Washington, for a period of at least three (3) years after the final grant payment or loan repayment, or any dispute resolution hereunder.
- RECIPIENT shall provide clarification and make necessary adjustments if any audits or inspections identify discrepancies in the records.

ECOLOGY reserves the right to audit, or have a designated third party audit, applicable records to ensure that the state has been properly invoiced. Any remedies and penalties allowed by law to recover monies determined owed will be enforced. Repetitive instances of incorrect invoicing or inadequate records may be considered cause for termination.

All work performed under this Agreement and any property and equipment purchased shall be made available to ECOLOGY and to any authorized state, federal or local representative for inspection at any time during the course of this Agreement and for at least three (3) years following grant or loan termination or dispute resolution hereunder.

RECIPIENT shall provide right of access to ECOLOGY, or any other authorized representative, at all reasonable times, in order to monitor and evaluate performance, compliance, and any other conditions under this Agreement.

23. RECOVERY OF FUNDS

The right of the RECIPIENT to retain monies received as reimbursement payments is contingent upon satisfactory performance of this Agreement and completion of the work described in the Scope of Work.

All payments to the RECIPIENT are subject to approval and audit by ECOLOGY, and any unauthorized expenditure(s) or unallowable cost charged to this Agreement shall be refunded to ECOLOGY by the RECIPIENT.

24. SEVERABILITY

a) For Cause

ECOLOGY may terminate for cause this Agreement with a seven (7) calendar days prior written notification to the RECIPIENT, at the sole discretion of ECOLOGY, for failing to perform an Agreement requirement or for a material breach of any term or condition. If this Agreement is so terminated, the parties shall be liable only for performance rendered or costs incurred in accordance with the terms of this Agreement prior to the effective date of termination.

Failure to Commence Work. ECOLOGY reserves the right to terminate this Agreement if RECIPIENT fails to commence work on the project funded within four (4) months after the effective date of this Agreement, or by any date mutually agreed upon in writing for commencement of work, or the time period defined within the Scope of Work.

Non-Performance. The obligation of ECOLOGY to the RECIPIENT is contingent upon satisfactory performance by the RECIPIENT of all of its obligations under this Agreement. In the event the RECIPIENT unjustifiably fails, in the opinion of ECOLOGY, to perform any obligation required of it by this Agreement, ECOLOGY may refuse to pay any further funds, terminate in whole or in part this Agreement, and exercise any other rights under this Agreement.

Despite the above, the RECIPIENT shall not be relieved of any liability to ECOLOGY for damages sustained by ECOLOGY and the State of Washington because of any breach of this Agreement by the RECIPIENT. ECOLOGY may withhold payments for the purpose of setoff until such time as the exact amount of damages due ECOLOGY from the RECIPIENT is determined.

b) For Convenience

ECOLOGY may terminate for convenience this Agreement, in whole or in part, for any reason when it is the best interest of ECOLOGY, with a thirty (30) calendar days prior written notification to the RECIPIENT, except as noted below. If this Agreement is so terminated, the parties shall be liable only for performance rendered or costs incurred in accordance with the terms of this Agreement prior to the effective date of termination.

Non-Allocation of Funds. ECOLOGY's ability to make payments is contingent on availability of funding. In the event funding from state, federal or other sources is withdrawn, reduced, or limited in any way after the effective date and prior to the completion or expiration date of this Agreement, ECOLOGY, at its sole discretion, may elect to terminate the Agreement, in whole or part, or renegotiate the Agreement, subject to new funding limitations or conditions. ECOLOGY may also elect to suspend performance of the Agreement until ECOLOGY determines the funding insufficiency is resolved. ECOLOGY may exercise any of these options with no notification or restrictions, although ECOLOGY will make a reasonable attempt to provide notice.

29. THIRD PARTY BENEFICIARY

RECIPIENT shall ensure that in all subcontracts entered into by the RECIPIENT pursuant to this Agreement, the state of Washington is named as an express third party beneficiary of such subcontracts with full rights as such.

30. WAIVER

Waiver of a default or breach of any provision of this Agreement is not a waiver of any subsequent default or breach, and will not be construed as a modification of the terms of this Agreement unless stated as such in writing by the authorized representative of ECOLOGY.
