Directly prior to going to work for King County, I worked in journalism as both a reporter and an editor, covering a wide range of issues including government, business and transportation.

I hold a bachelor's degree in journalism from Western Washington University.

Please describe why you're interested in serving on this Advisory Group.

I was born and raised in Chimacum, on the Olympic Peninsula, where ferries were always a part of my life. Aside from using the ferries for visiting friends and making day trips when I was a kid, they were integral to my daily commute when I later worked in commercial construction. The Port Townsend ferry is, of course, a sore spot for some residents with its tidal cancellation issues and the many issues with boats over the years. I also covered the Washington State Ferries as part of my transportation beat when I worked at the Seattle P-I, where I got an inside look at how the ferry system runs. And the Lummi Island ferry was one of the first day trips I took after I moved to Bellingham the first time in 2012. It's easy to see that this system is vital to the residents of Lummi but likely also comes with some significant challenges.

Suffice to say ferries are an issue close to my heart, of great interest, and one with which I'm well acquainted.
