The Whatcom County Council will consider adopting and may amend the following at its 6 p.m. meeting on April 9, 2024, or at a later date: ORDINANCE CALLING FOR THE ELECTION OF CHARTER REVIEW COMMISSIONERS AT THE NOVEMBER 2024 GENERAL ELECTION (AB2024-210): This ordinance, per Whatcom County Charter Section 8.11, calls for the election of a Charter Review Commission, consisting of lifteen persons, an equal number from each council district. There shall be no filing the nor shall there be a primary. The qualified voters of the respective districts shall vote only for candidates from their district at the general election. Candidates' names shall appear on all hallots as drawn by bit. The member of the Commission who receives the greatest number of votes shall cowner the Commission. The term of office shall be one year. The Commission shall meet at such times and in such places as it deems appropriate upon having given public notice. Registered voters who wish to represent their district on the 2025 Charter Review Commission must file a declaration of candidacy with the Whatcom County Auditor's Office during filing week, May 6 – 10, 2024.
