FIRST AMENDMENT TO INTERLOCAL AGREEMENT BETWEEN WHATCOM COUNTY AND THE CITY OF BELLINGHAM FOR LAKE WHATCOM FOREST MANAGEMENT PLAN PARTNERSHIP (CITY CONTRACT NO. C2401145; COUNTY CONTRACT NO. 202409022)

THIS FIRST AMENDMENT ("Amendment") is entered into by and between the City of Bellingham (the "City") and Whatcom County (the "County").

WHEREAS, the City and the County are parties to that certain Interlocal Agreement for Lake Whatcom Forest Management Plan Partnership (County Contract No. 202409022; City Contract No. C2401145) ("Agreement"); and

WHEREAS, the Agreement defines a partnership between the City and County to develop a forest management plan with Northwest Natural Resources Group ("the Contractor") that will provide coordinated recommendations for the City and County that will focus on actions that positively impact water quality and forest health; and

WHEREAS, the parties desire to modify the Agreement to increase the City's financial contribution to reflect the City's recent purchase of 754 acres of watershed property, known as the Blue Canyon Preserve properties.

NOW, THEREFORE, the Parties Agree as follows:

1. <u>Modification</u>. Section 3 of the Agreement is repealed and replaced in its entirety with the following language:

The total contract amount with the Contractor for forest management plan development is \$145,123. The amount of payment by the City to the County under this Agreement will be a maximum of \$53,358. The County's maximum responsibility is \$91,795.

- (a) Payments to the County by the City will be made quarterly based on invoices submitted to the City.
- (b) The City shall promptly review and process invoices in accordance with its usual procedures.
- **2.** Remaining Terms Unchanged. All other terms and conditions of the Agreement remain unchanged and in full force and effect.
