**ORDINANCE ADOPTING AMENDMENTS TO WHATCOM COUNTY CODE TITLE 15 (BUILDINGS & CONSTRUCTION) TO ADOPT BY REFERENCE THE 2018 EDITIONS OF THE INTERNATIONAL BUILDING AND OTHER ASSOCIATED CODES (AB2021-096):** This ordinance adopts amendments to Whatcom County Code Title 15 (Buildings & Construction) to adopt by reference the 2018 Editions of the International Building, Residential, Mechanical, Fuel Gas, Existing Building, Fire Codes, and the National Fuel Gas, Washington State Energy, Uniform Plumbing, & Liquefied Petroleum Gas Codes, and the 1997 Uniform Code for the Abatement of Dangerous Buildings, as amended as set forth herein, as required by RCW Chapter 19.27. This ordinance was introduced on February 9, 2021.

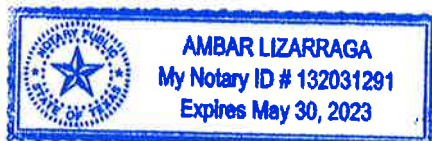
