12	WHEREAS, RCW 36.35.120 requires the Council to establish the minimum price
13	for said unit of property and to determine whether or not a contract will be allowed, or if
14	it will be a cash price; and,

16	WHEREAS, the Whatcom County Property Management Committee
17	recommends that the Property be offered for sale by public auction for a price not less
