Enclosed for your consideration is the proposed agreement between Whatcom County and Justice AV Solutions (JAVS) for equipment to upgrade the audio visual recording system in Superior Court Courtroom 4C.

• **Background and Purpose**

The Superior Court courtroom 4C has an unsupported and end-of-life JAVS audio visual recording system. This agreement would upgrade the JAVS system in Courtroom 4C with a number of "Courtroom of the Future" advanced technologies to increase access to justice. This includes:

- 60 Inch Touchscreen Displays for Annotation
- Document Camera for Presentation and Signature Capture
- Direct Integration with Zoom and Teams Video Conferencing Systems

This is a sole source procurement. Superior Court, Juvenile Court, District Court, Sheriff's Office, City of Bellingham Municipal Court and City of Ferndale Municipal Court currently have 11 JAVS systems and it is important to maintain full compatibility between these systems.

• **Funding Amount and Source**

The amount of the agreement is \$69,318.59 and the source of funding is a reimbursable agreement with the State of Washington Administrative Office of the Courts for a maximum of \$100,000.00.
