ACTION TAKEN

The Whatcom County Council adopted the following at its 6 p.m. meeting on December 6, 2022: **ORDINANCE (2022-087) TO INSTALL STOP SIGNS ON BAY ROAD AT THE INTERSECTION WITH KICKERVILLE ROAD (AB2022-651)** This ordinance allows for the installation of stop signs for eastbound and westbound traffic on Bay Road at the intersection with Kickerville Road. Ordinance introduced November 22, 2022. **ORDINANCE (2022-088) TO INSTALL STOP SIGNS ON BAY ROAD AT THE INTERSECTION WITH VALLEY VIEW ROAD (AB2022-652)** This ordinance allows for the installation of stop signs for eastbound and westbound traffic on Bay Road at the intersection with Valley View Road. Ordinance introduced November 22, 2022. **ORDINANCE (2022-089) TO REMOVE STOP SIGNS ON HARKSELL ROAD AT THE INTERSECTION WITH WOODLAND ROAD (AB2022-654)** This ordinance allows for the removal of stop signs for eastbound and westbound traffic on Harksell Road at the intersection with Woodland Road. Ordinance introduced November 22, 2022. **RESOLUTION (2022-051) TO DECLARE WHATCOM COUNTY REAL PROPERTY AS SURPLUS AND APPROVE SALE (AB2022-581)** This resolution declares as surplus and approves the sale of Whatcom County real property tax parcel 390225 443267 0000, legally described as The southerlymost 15 feet of the northeast quarter of Section 25, Township 39 North, Range 2 East, W.M; excepting therefrom State Highway No. 539 (Guide Meridian Road). Per RCW 36.34.005 and Whatcom County Code 1.10, the Whatcom County Property Management Committee has recommended to surplus and sell said property subject to a covenant to bind to the highest bidder who could legally purchase the property, by sealed bid with the minimum sale price of \$890.00 (eight hundred ninety 00/100 dollars), which is the market value. Resolution introduced November 9, 2022. **ORDINANCE (2022-090) AUTHORIZING THE 2023 WHATCOM COUNTY UNIFIED FEE SCHEDULE (AB2022-665)** This ordinance adopts a centralized listing of fees charged by Whatcom County, a complete listing of which can be viewed online via the Council's Legislative information center at Whatcom.legistar.com. A copy can also be requested by calling the Council office at 360-778-5010 or visiting the office in person at 311 Grand Ave, Suite 105, Bellingham. **ORDINANCE (2022-091) AMENDING WHATCOM COUNTY CODE CHAPTER 3.72 (CONSTRUCTION PROJECTS-APPRENTICESHIP REQUIREMENTS) TO EXTEND THE START DATES AND ENHANCE THE REQUIREMENTS FOR UTILIZATION OF THE CONTRACTOR APPRENTICESHIP PROGRAM (AB2022-673)** This ordinance amends Whatcom County Code Chapter 3.72 to modify the effective dates and clarify timing for exceptions and waivers of apprenticeship requirements for construction projects. Ordinance introduced November 22, 2022. **ORDINANCE (2022-092) AUTHORIZING THE LEVY OF TAXES FOR WHATCOM COUNTY AND STATE PURPOSES IN WHATCOM COUNTY FOR THE YEAR 2023 (AB2022-688)** This ordinance authorizes the levy of taxes for 2023 in accordance with RCW 84.55. Ordinance introduced November 22, 2022. **ORDINANCE (2022-093) AMENDING WHATCOM COUNTY CODE 2.118, REACTIVATING THE WHATCOM COUNTY WILDLIFE ADVISORY COMMITTEE BEYOND DECEMBER 31, 2022 (AB2022-636)** This ordinance authorizes the continuation of the Whatcom county Wildlife advisory Committee until December 31, 2026 so they may continue working on wildlife related issues in Whatcom County. Ordinance introduced November 22, 2022. **ORDINANCE (AB2022-094) AMENDING WHATCOM COUNTY CODE 16.20, WHATCOM COUNTY SHELLFISH PROTECTION DISTRICTS (AB2022-661)** This ordinance amends Whatcom County Code 16.20, Whatcom County Shellfish Protection Districts, by extending the sunset date for the Drayton Harbor, Portage Bay, and Birch Bay Shellfish Protection Districts to December 31, 2026 so that necessary improvements in water quality may be achieved in these districts. Ordinance introduced November 22, 2022. **ORDINANCE (2022-095) AMENDING THE SILVER BEACH CREEK STORMWATER IMPROVEMENTS PROJECT FUND, REQUEST NO. 1 (AB2022-657)** This ordinance amends the Silver Beach Creek Stormwater Improvements Project Fund to include Phase II of this project as part of the work contemplated and approved in Ordinance No. 2020-040. Ordinance introduced November 22, 2022. **ORDINANCE (2022-096) AMENDING THE 2023 WHATCOM COUNTY BUDGET, REQUEST NO. 1, IN THE AMOUNT OF \$9,737,304 (AB2022-659)** This ordinance amends the 2023 Whatcom County Budget as follows: From the Road Fund, appropriate \$9,737,304 to fund the Annual Construction Program. Ordinance introduced November 22, 2022. **ORDINANCE (2022-097) AMENDING THE PROJECT BASED BUDGET FOR THE NORTH LAKE SAMISH ROAD BRIDGE NO. 107 REPLACEMENT FUND, REQUEST NO. 2 (AB2022-660)** This ordinance appropriates \$1,027,368 to the North Lake Samish Road Bridge No. 107 Replacement Fund in order to fund additional preliminary engineering and construction costs for a total project budget of \$12, 272,368. Ordinance introduced November 22, 2022. **ORDINANCE (2022-098) AMENDING THE 2022 WHATCOM COUNTY BUDGET, REQUEST NO. 16, IN THE AMOUNT OF \$636,513 (AB2022-662)** This ordinance amends the 2022 Whatcom County Budget as follows: From the General Fund: appropriate \$20,000 in Sheriff to fund 2022 Aquatic Invasive Species Program overtime from Flood Fund transfer; appropriate \$14,001 in Sheriff to fund ballistic vests from grant proceeds; appropriate \$102,512 in Sheriff to fund reimbursable overtime increase. From the Emergency Management Fund, appropriate \$500,000 to fund additional November 2021 flood assistance from grant proceeds. Ordinance introduced November 22, 2022. Public documents are available for review weekdays from 8:30 a.m. to 4:30 p.m. in the Council Office, 311 Grand Avenue, Suite 105, Bellingham, and at whatcomcounty.us/council. View meeting schedules, agendas, minutes, videos, documents and archives at whatcom.legistar.com. The Council is currently holding hybrid meetings, which can be attended either in person or remotely. Full Council meetings begin at 6 p.m. (unless otherwise announced) in the Council Chambers at 311 Grand Avenue. 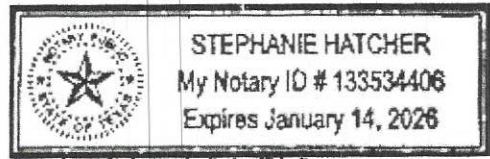
