RE: Meeting procedures: discussion items on day of introduction

---

At the February 17, 2026 Council Retreat, it was requested that staff assist Councilmembers Galloway and Scanlon in compiling information on an approach to limiting discussion of items on the day of their introduction to address efficiency so that not all introduction items get discussed.

### Historical Practice

Historical practice was to introduce items at one meeting and then at the next meeting day discuss it in committee and act on it in the evening. The introduction at the first meeting is the equivalent to having the council approve the item being added for discussion and action at the next meeting. If the council has edits in committee discussion on the day of action, the item could be

1. motion to send item back to committee at next meeting for further edits, or
2. a new version (if substantive edits in committee) introduced that evening.

When agenda preparers felt there could be substantive changes, they would schedule a discussion item in committee on the day of introduction.

### Recent Procedural Changes

On 4/1/2025, council passed a motion to change the order of operations so that they hear (agenda) items (ordinances and resolutions requiring an ordinance-like process) in committee prior to introduction. After this change, councilmembers found that some items were placed on agendas four times and that may be more than needed for some items.

### Next Steps

**Attached is a chart** that includes all the introduction items for 2024-2025 for reference of the types and number of items on introduction in a given year. Councilmembers Scanlon and Galloway suggest discussion on the day of introduction only for the following items:

1. Ordinances amending the county budget
2. Ordinances requiring a public hearing (not resolutions requiring a public hearing)
3. All official recurring county plans or plan updates (see attached list for reference)
4. Additional items at the discretion of the agenda bill drafter or councilmember - e.g. if the item will likely be substantively changed after introduction.

Councilmembers may establish a new procedure through the following motions:

- *I move to rescind the motion passed on April 1, 2025 to require discussion on the day of introduction*
- *I move to require discussion in committee on the day of introduction for the following:*  
ordinances amending the county budget, ordinances requiring a public hearing, all official recurring county plans or plan updates.
