### COUNCIL ACTION TAKEN

The Whatcom County Council adopted the following at its August 5, 2020 meeting:

**ORDINANCE (2020-041) REGARDING INSTALLATION OF STOP SIGNS ON CERTAIN COUNTY ROADS (AB2020-291):** This ordinance will correct a scrivener's error in Whatcom County Ordinance 1987-009 and allow for the installation to reestablish all-way stop control at Everson Goshen Road and E. Smith Road intersection. During preparations for the E. Smith Road Pavement Rehabilitation Project it was discovered that a scrivener's error existed on Page 7 of Appendix A that is referenced in Ordinance 1987-009. That page listed a stop sign as located at Everson Goshen Road southbound at E. Hemmi Road where it should have been listed as located at Everson Goshen Road southbound at E. Smith Road. Council introduced above at its July 21, 2020 meeting.

**ORDINANCE (2020-042) AMENDING THE 2020 BUDGET REQUEST NO. 15 IN THE AMOUNT OF \$716,503 (AB2020-297):** This ordinance amends the Budget in the amount of \$716,503. Included therein: \$492,687 Sheriff to fund Operation Stonegarden; \$12,500 in Sheriff to fund the Organized Crime Drug Enforcement Task Force; \$28,800 in Sheriff to fund marine patrols; \$9,000 in Sheriff to fund recreational boating safety patrols; \$49,169 in Non-Departmental to fund What-Comm E911 Operations; \$124,347 in Health 2 FTE's for new staff and extra help for COVID-19 response. This ordinance was introduced on July 21, 2020.

**RESOLUTION (2020-031) AUTHORIZING THE COUNTY EXECUTIVE TO ENTER INTO A TWENTY-YEAR COMMUNICATION TOWER LEASE AGREEMENT WITH CELCO PARTNERSHIP d/b/a VERIZON WIRELESS (AB2020-253):** This Resolution authorizes the County Executive to enter into a twenty-year communication tower lease agreement with Celco Partnership d/b/a Verizon Wireless for leased space on park property located at the Lookout Mountain Forest Preserve as outlined in the agreement. Council introduced above at its July 7, 2020 meeting.

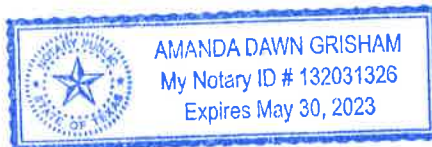
