**AMENDMENT No. 1
TO
INTERLOCAL FUNDING AGREEMENT BETWEEN
WHATCOM COUNTY AND THE CITY OF BELLINGHAM FOR
SUPPORT OF U.S. GEOLOGICAL SURVEY'S DEVELOPMENT AND
IMPLEMENTATION OF THE COASTAL STORM MODELING SYSTEM
ACROSS THE WHATCOM COUNTY SHORELINE**

WHEREAS, an interlocal agreement ("Agreement") was entered into between the City of Bellingham ("City") and Whatcom County ("County") on December 3, 2019 (City Contract No. 2019-0638 and County Contract No. 201909005) for the purpose of developing and implementing a Coastal Storm Modeling System ("CoSMoS") across the Whatcom County shoreline to evaluate impending coastal hazards and inform hazard mitigation and adaptation planning for property, infrastructure, habitats and restoration actions; and,

WHEREAS, the County agreed to reimburse the City for City-incurred expenses related to management and administration of the CoSMoS project according to the terms described in the Agreement; and,

WHEREAS, the agreement envisioned that the portion of the project that would be billed to the County would be completed in 2019 and 2020 and stipulated that the County would be billed for services by the end of 2020 even though the term of the interlocal agreement continued through July 31, 2021; and,

WHEREAS, implementation of significant portions of the project and thus the compensation for those services was delayed into 2021; and,

WHEREAS, the City desires modification of the agreement to allow the County to compensate the City for services rendered in 2021 and to allow more time to complete the project.

NOW, THEREFORE, the City and the County agree as follows:

1. TERM. That Section 1 (a) of the Agreement is amended as follows:

1 (a) (Amended): This Agreement shall be effective August 1, 2019 and shall continue through December 31, 2021, unless terminated pursuant to part (b) below.

3. COUNTY RESPONSIBILITIES. That Section 3 (a) of the Agreement is amended as follows:

3 (a) (Amended): The County shall contribute the following amounts to the Project: Ten Thousand Dollars (\$10,000) in year 2020 and One Hundred and Fifteen Thousand Dollars (\$115,000) in year 2021.

FURTHER, unless specifically stated herein, all other terms and conditions of the original agreement shall remain in full force and effect.
