**FIRST MODIFICATION TO INTERLOCAL AGREEMENT
BETWEEN CITY OF BELLINGHAM AND WHATCOM COUNTY
CONTRACT # C2200406**

The **CITY OF BELLINGHAM**, a first class municipal corporation of the State of Washington (hereinafter the "City"), and **WHATCOM COUNTY** (hereinafter the "County"), in consideration of the mutual covenants herein, agree as follows:

1. **EXISTING AGREEMENT MODIFIED:** The City and the County entered into the Agreement, dated May 5, 2022 which is incorporated herein by this reference (hereinafter the "Agreement"). The parties hereby modify that Agreement.
2. **MODIFICATIONS TO EXISTING AGREEMENT:** The Agreement is modified in the following respects:
 - 2.1 The Payment, as originally set forth in Section 3.1, is hereby modified to increase the subscriber fee effective January 1, 2023. The new rate will be \$25 per radio per month. The basis for the increase is detailed in Exhibit "A" attached and incorporated herein by this reference.
3. **TERMS AND CONDITIONS OF EXISTING AGREEMENT REMAIN THE SAME:** The parties agree that, except as specifically provided in this modification, the terms and conditions of the Agreement continue in full force and effect.





The interlocal Agreement (C2200406) between the City of Bellingham and the Whatcom County Sheriff's Office allows for an annual review of the subscriber rate charged for use of our system. We are required to notify you of any change of rate for the next year by September 1 of the previous year. This letter serves as notification that we intend to increase the subscriber fees for 2023. Please refer to Section 3.1 of that agreement for any clarification.

The initial rate of \$20.00 per month / per radio was a starting place, and a rate I insisted we stick to as it was previously approved by my supervisor and verbally passed on to you as the beginning rate for use of our system.

It has become clear that due to increases in costs of equipment and maintenance on the system, and comparisons to the rates charged by similar private and public systems, we need to introduce an increase in that fee for 2023. We have decided to implement an increase of 25% for 2023; the maximum increase allowed by the ILA. The new rate for 2023 will be \$25 per radio / per month.

That amount will be invoiced to you in January for the 21 radios in use. Between now and then, our contracts staff will be in touch with an amended interlocal agreement for your signature. As we are amending the document, we would like to take the opportunity to update any contact information that may be out of date. Please check that information on the attached copy of the ILA and let me know if any updates are required.

Also attached please find a current inventory of your subscribers as listed in the systems database. Please work with your radio service vendor to validate its accuracy. We can make any required adjustments prior to billing in January 2023.


