#### ORDINANCE INCREASING COMMUNITY OVERSIGHT AND TRANSPARENCY TO ESTABLISH FAIR CONTRACT NEGOTIATIONS (AB2020-409):

This ordinance requires that the County conduct collective bargaining contract negotiations in a manner viewable by the public in real time and sets rules for negotiation observers and distribution of meeting notices and materials. This ordinance was introduced on September 29, 2020.

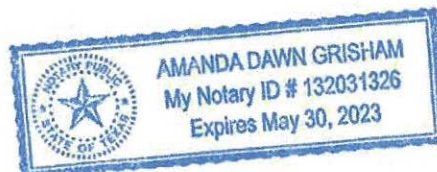
