**CLARIFICATION OF WHATCOM COUNTY COUNCIL RESOLUTION 2020-052**

A clerical error occurred in Whatcom County Council's resolution 2020-052, Certifying Property Tax Levies for Collection in 2021 to the County Assessor. The Nooksack Valley School District general fund/enrichment levy was certified at \$25,015,747.14. The correct amount should have been \$2,500,000. The Assessor's office adjusted the actual levy to \$3,123,229.15, which was the state maximum of \$2.50 per \$1000 of assessed value. This levy error will be corrected over two years, per the District's preference. The Nooksack Valley School District's debt service fund/bond was certified at \$3,429,886.83; the correct amount should have been \$3,445,633.77. This levy error will be corrected in 2022. The district was notified of the final levy amounts Jan 19, 2021. Publish December 1, 2021. IPL0051138 Dec 1 2021

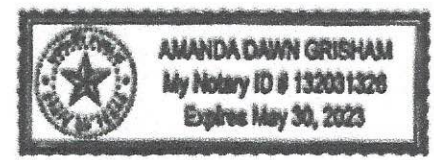
