The Whatcom County Council will consider adopting and may amend the following at its November 10, 2020, meeting or at a later date:

**ORDINANCE DESIGNATING A COMMERCIAL PROPERTY ASSESSED CLEAN ENERGY AND RESILIENCY (C-PACER) PROGRAM WITHIN WHATCOM COUNTY (AB2020-448):** This ordinance would adopt a C-PACER Program designating a commercial property assessed clean energy and resiliency program within Whatcom County. This ordinance was introduced on October 27, 2020.

**ORDINANCE AMENDING THE PROJECT BUDGET FOR THE CIVIC CENTER IMPROVEMENT FUND, REQUEST NO. 1 IN THE AMOUNT OF \$4,350,000 (AB2020-449):** This ordinance request \$4,350,000 of additional budget authority to provide for life safety and energy efficiency improvements throughout the entire building, in addition to fourth floor renovations, for a total project budget amount of \$6,850,000. This ordinance was introduced on October 27, 2020.

**ORDINANCE AMENDING THE 2020 WHATCOM COUNTY BUDGET, REQUEST NO. 20, IN THE AMOUNT OF \$4,476,128 (AB2020-450):** This ordinance requests: \$3,850,000 to fund transfer in support of Civic Center Improvement Fund renovation project. From the Election Reserve Fund: \$126,128 to fund addition 2020 General Election costs from Center for Tech and Civic Life grant proceeds. From Real Estate Excise Tax, 1 Fund: \$500,000 to fund transfer in support of Civic Center Improvement Fund renovation project. This ordinance was introduced on October 27, 2020.

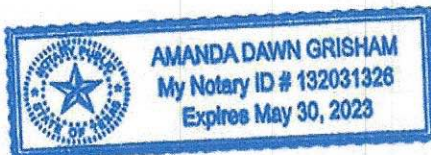
