I am semi-retired, having devoted my professional career to public service in various capacities that included social work with elderly and disabled clients, as well as operational and administrative responsibilities in a large metropolitan police department, before returning to school to study law. After becoming an attorney in 1990, my career continued in local government, primarily in defense litigation. This experience has provided me with insight into the needs and limitations of multiple government agencies. I retired from the full-time practice of law in 2016 and am now self-employed providing dispute resolution services as an Arbitrator and Mediator, which has given me insight into the competing interests of parties in various walks of life.

I also have undergraduate degrees in Criminal Justice and Psychology, during which time I interned in a women's prison in Florida where I was able to interact directly with prisoners and staff. Later on I represented jail/prison employees in various legal matters. Both experiences provided considerable insight into the challenges facing those systems as well as the individuals who had ended up there.

10. Please describe why you're interested in serving on this board or commission

I firmly believe in community involvement. Although it is human nature for people to complain, I believe that you shouldn't complain if you're not willing to participate and try to improve things. Volunteer service on community boards is one way to do that. For 13 years I served on the Planning and Zoning board where I used to live in Davie, FL, and found it very rewarding to have that involvement and input in the growth of my community. Having worked for several years in the law enforcement area, I've seen firsthand that incarceration is not always the "right fit" for every transgression in society, and believe that I could provide some insight into possible improvements. Having recently moved to Washington state, I would welcome the opportunity to serve in some kind of community capacity and this board, given its focus and purpose, seemed the most appropriate given my background.
