This Amendment increases the maximum annual consideration by \$69,000.00 to a total annual consideration of \$149,000.00. This also increases the annual number of hours worked from 266.5 to 496.

This Amendment takes effect: May 1, 2025, regardless of the date of signature, and expires December 31, 2025.
