ORDINANCE NO. 2022-031

**ESTABLISHING PARKING CONTROL ON EDDIE LANE WITHIN THE PLAT OF
WHISPER LAKE**

WHEREAS, in compliance with RCW 46.61.570, it is found necessary and expedient to place traffic control signs on certain County Roads; and

WHEREAS, the creation of a no parking zone was a requirement of the County for subdivision approval of The Plat of Whisper Lake; and

WHEREAS, it was found that the following newly constructed roadway within the subdivision should be fitted with no parking signs; and

NOW, THEREFORE, BE IT ORDAINED by the Whatcom County Council that a No Parking Anytime zone be established on the north side of Eddie Ln within the Plat of Whisper Lake, located within Section 31, Township 40 North, Range 1 East, W.M.


BE IT FURTHER ORDAINED, by the Whatcom County Council that the following be added to the Whatcom County Code, Section 10.24.255:

10.24.255 Eddie Ln.


"No Parking Anytime" signs shall be placed on the north side of Eddie Lane from SR-548/Blaine Road westerly to the cul-de-sac, located within Section 31, Township 40 North, Range 1 East, W.M.

BE IT FURTHER ORDAINED, that the County Engineer is hereby directed to install the appropriate signage and the Whatcom County Sheriff and Washington State Patrol be notified by a copy of this ordinance.
