RE: 2024 WA State Legislative Session Planning – July 25 COTW Discussion

Overview:

The Administration is working to increase County Council, Elected Official, and Department Head Engagement in establishing – and advocating for – the County's state legislative agenda. As we plan for the 2024 60-day state legislative session, the Administration will facilitate a series of activities to collaboratively develop a set of legislative priorities and budget asks.

The July 25th Committee of the Whole meeting will be the initial opportunity for Council/Executive discussion on 2024 legislative priorities.

Proposed Schedule of Engagement:

The Administration proposes the below schedule for developing the County's priorities and engaging with the delegation during the legislative interim. The following dates are tentative.

Setting an Agenda:

The Administration has drafted an initial list of priorities and budget requests (listed below) to kick-start discussion. This list will grow significantly as the Administration consults with Council, Departments, other County elected officials, WSAC, the Port of Bellingham, City of Bellingham and other community partners. Ultimately, the Administration anticipates developing a "lead" agenda with specific County budget and policy requests (i.e. Swift Creek cleanup) and a "support" agenda with broader issues the County wishes to track (i.e. funding for public defense.)

Initial List of Policy Issues:

- Land Use
 - Urban Growth Areas "Land Swap" working with small cities to determine RCW changes needed to direct development to less flood-prone areas
 - Increasing appropriate development Limited areas of more intense rural development (LMIRDs) and ADUs in rural areas
- Affordable Housing
 - Economic Development Investment Program "technical fix" bill clarification to allow use of EDI funds for workforce housing and land banking
- Behavioral Health
 - Ensuring appropriate Medicaid reimbursement rates and coverage for care, including at a 23-hour crisis relief center
 - Supporting efforts to bolster the behavioral health workforce

Initial List of Budget Requests:

- Capital
 - Swift Creek cleanup
 - Justice Project plan priorities re-entry center; inpatient beds
- Operating
 - Fund the 90-day Medicaid waiver for jail-based health
 - Continued support on floodplain management, water solutions, and natural resources
 - Behavioral health diversion programs, including a potential prosecutorial diversion pilot and/or alternative pathways for competency restoration
