THIS AMENDMENT is to the Contract between Whatcom County and MORE Smiles Learning Center, dated September 30, 2020 and designated "Whatcom County Contract No. 202009009". In consideration of the mutual benefits to be derived, the parties agree to the following:

This Amendment increases the maximum consideration by \$50,000 for a total consideration of \$100,000.

This Amendment also adds the attached Exhibit D, Invoice Template to ensure adequate billing records are received. The contractor is required to submit monthly "Year to Date" Expenditure and Revenue reports with their billing statement using the Invoice Template included in Exhibit D.

Unless specifically amended by this agreement, all other terms and conditions of the original contract shall remain in full force and effect.

This Amendment takes effect: October 29, 2020, regardless of the date of signature.
