CHANGING THE NAME OF BEAR TRAP ROAD TO BEAR SPIRIT ROAD

**WHEREAS**, Mrs. Shauna Boyd requesting revision of the road name due to the somewhat violent connotation that Bear "Trap" Road presents; and

**WHEREAS**, local residents have no objection to changing their road name to Bear Spirit Road; and


**NOW, THEREFORE, BE IT ORDAINED** by the Whatcom County Council that the name of Bear Trap Road be changed to Bear Spirit Road:
