**ACTION TAKEN**

The Whatcom County Council adopted the following at its September 12, 2023, meeting: **ORDINANCE (2023-049) ESTABLISHING PARKING RESTRICTIONS ON EUCLID AVENUE AS WHATCOM COUNTY CODE 10.24.260 (AB2023-526)**: This ordinance adds a new section to Whatcom County Code 10.24 to establish a "No Parking" zone on Euclid Avenue from 10:00 p.m. to 6:00 a.m. on the east side of Euclid Avenue from approximately 735 feet south of Crescent Street at the north to Glen Cove Lane to the south. This ordinance was introduced on August 8, 2023. **ORDINANCE (2023-050) ESTABLISHING PARKING RESTRICTIONS ON SAMISH WAY (AB2023-501)**: This ordinance adds a new section to Whatcom County Code 10.24 to establish a "No Parking" zone on Samish Way, 500 feet east of Galbraith Lane and 500 feet west of Galbraith Lane on the south side of the road. This ordinance was introduced on August 8, 2023. **ORDINANCE (2023-051) ESTABLISHING PARKING RESTRICTIONS ON ALDRICH ROAD AS WHATCOM COUNTY CODE 10.24.265 (AB2023-528)**: This ordinance adds a new section to Whatcom County Code 10.24 to establish a "No Parking" zone on both sides of Aldrich Road from the southerly intersection of the Right-of-Way of Waldron Road to the Bellingham City Limits. This ordinance was introduced on August 8, 2023. **ORDINANCE (2023-052) AMENDING THE PROJECT BUDGET FOR THE JAIL IMPROVEMENT FUND, REQUEST NO. 6 (AB2023-507)**: This ordinance amends the project-based budget for the Jail Improvement Fund (request no. 6) to appropriate \$88,000 to fund replacement of a failing hot water boiler used for the jail kitchen and laundry, for a total project budget of \$9,632,700. This ordinance was introduced on August 8, 2023. **ORDINANCE (2023-053) AMENDING THE 2023 WHATCOM COUNTY BUDGET, REQUEST NO. 12, IN THE AMOUNT OF \$2,126,139 (AB2023-508)**: This ordinance amends the 2023 Whatcom County Budget as follows: This ordinance amends the 2023 Whatcom County Budget as follows: From the General Fund - appropriate \$49,050 in Non-Departmental to fund What-Comm E911 Ops 2023-24 from grant proceeds; appropriate \$592,950 in Planning and Development Services to fund Comprehensive Plan Update from grant proceeds; appropriate \$4,675 in Parks and Recreation to fund replacement of Semiahmoo Park Interpretive Sign; appropriate \$41,997 in Health to fund Opioid Program Specialist position from grant proceeds; appropriate \$33,997 in Health to fund Human Services labor pool adjustment (companion to Supplemental #4045 Opioid Program Specialist position); record operating transfer of \$8,459 to the General Fund in Health (companion supplemental for #4049/#4050 Healthy Children's Fund Specialist); appropriate \$6,328 in Health to fund companion supplemental #4052 New Community Health Assistant Manager position; appropriate \$31,636 in Health to fund Human Services labor pool adjustment, companion to Supplementals #4052, #4053, #4054, #4055, #4056 funding Community Health Assistant Manager position; record \$6,328 in Health to fund Human Services indirect adjustment (companion to Supplementals #4052, #4053, #4054, #4055, #4056); appropriate \$14,702 in Sheriff to fund increase for two rescue boats. From the Veterans Relief Fund - appropriate \$7,909 to fund companion supplemental #4052 New Community Health Assistant Manager position. From the Jail Fund - appropriate \$88,000 to fund replacement of hot water heater for Jail kitchen. From the Behavioral Health Program Fund - appropriate \$7,909 to fund companion supplemental #4052 New Community Health Assistant Manager position. From the Parks Special Revenue Fund - appropriate \$4,675 to fund companion supplemental #4042 Semiahmoo signage. From the Mental Health and Developmental Disabilities to fund 1590 Capital Funding in support of new multi-unit affordable housing project. From the Affordable Housing, Behavioral Health Fund - appropriate \$1,000,000 Family Program Specialist position; appropriate \$33,997 to fund Healthy Children's Fund Specialist labor pool adjustment (companion to #4049); appropriate \$7,909 to fund companion supplemental #4052 New Community Health Assistant Manager position. From the Real Estate Excise Tax I Fund - appropriate \$20,000 in Administrative Services - Facilities to fund Assessor Office remodel; appropriate \$20,000 in Administrative Services - Facilities to fund Central Plaza first floor improvements. From the Public Utilities Improvement Fund - appropriate \$94,000 to fund Williamson Way water damage additional repairs. This ordinance was introduced August 8, 2023.

This ordinance was introduced on September 12, 2023. **RESOLUTION APPROVING THE WHATCOM COUNTY SIX-YEAR TRANSPORTATION IMPROVEMENT PLAN FOR THE YEARS 2024-2029 (AB2023-574)**: This resolution approves the Whatcom County Six-Year Transportation Improvement Program for the years 2024 through 2029, including the capital elements of the first six-years of the Fourteen-Year Ferry Capital Program. This resolution was introduced September 12, 2023.

This ordinance was introduced September 12, 2023. **RESOLUTION AMENDING THE FLOOD CONTROL ZONE DISTRICT & SUBZONES 2023 BUDGET, REQUEST NO. 2, IN THE AMOUNT OF \$665,792 (AB2023-591)**: This resolution amends the Flood Control Zone District & Subzones 2023 Budget as follows: From the Flood Control Zone District Fund - appropriate \$250,000 in Natural Resources to fund '23-'24 Legislative Water Management Proviso; appropriate \$59,175 in River and Flood to fund Flood and Flood Staffing Capacity; appropriate \$271,889 in Natural Resources to fund 2023 WCD PIC Technical Assistance; appropriate \$74,728 in Natural Resources to fund Natural Resources Culvert Staffing Capacity. This resolution was introduced September 12, 2023.

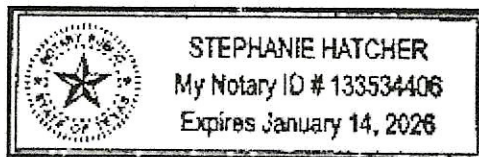
