The Whatcom County Council adopted the following at its August 8, 2023, meeting: ORDINANCE (2023-046) ESTABLISHING A TEMPORARY CLOSURE OF WEST SMITH ROAD FROM NORTH-WEST DRIVE TO THE FERRIDALE CITY LIMITS (AB2023-471): This ordinance temporarily closes West Smith Road from Northwest Drive to the Ferndale City limits in order to complete the decommissioning of a sewer line pump station.
