## County Council Vacancy in Public Health

My name is Shamika Brooks and I have been working in health care for over 18 years. I started out working as a certified nursing assistant while working my way through college to become a registered nurse. I have been a registered nurse for more than 13 years and a board certified family nurse practitioner for more than 6 years. As a family nurse practitioner, I am trained to care for individuals from birth throughout the entire life span.

I have worked throughout the continuum of healthcare from inpatient hospital care, medical case management, insurance case management, home health, and long term care medical management. Prior to moving to Washington state, I worked at a county hospital in Dallas, Texas for six years providing primary care and specialty care to those living with HIV and AIDS. Many of my patients were indigent and of low socioeconomic status. I understand the complexity in health care and the importance of access for everyone to reduce health disparities. In Texas, I was a part of a local county initiative to combat stigma and increase access to healthcare for those living with HIV/AIDS.

I am currently an adjunct faculty professor at a distance program at the University of Texas at Arlington. My joy is teaching future nurse practitioners and being involved in community efforts to improve access to health care. I have lectured health care providers and students about the health disparities dealing with those living with HIV/AIDS.

I would like to join the council in Public Health Advisory to bring my years of experience and passion to tackling the issue of healthcare access in Whatcom County. The Covid-19 pandemic landed a spotlight on the increasing issues with access to healthcare and health inequities already existing in the United States. As a result, I want to be actively engaged in helping create solutions for my community which will aid our efforts in increasing healthcare access to vulnerable populations.
