Bids were duly advertised to for the lease of four (4) vehicles. The Sheriff's Office Whatcom Gang and Drug Task Force will use these vehicles during the daily operations of the unit.

One (1) bid was received on 07/25/2023. Global Lease Group located in Lexington Massachusetts, submitted the only responsible bid. The F.O.B. delivery points provided were Bickford Ford in Snohomish Washington and Bellingham Nissan in Bellingham Washington. The bid details are as noted below:

Subject: Recommendation of Vendor for DTF Leased Vehicles (RFP #23-52)

Under RFP #23-52, The Whatcom County Sheriff's Office has received one bid for the leasing of four vehicles to be utilized by our Whatcom Gang and Drug Task Force. The lease would be for a 36 month period, beginning October 1st 2023, with the option of one additional 12 month lease at the end of the initial 36 months. After review of the bid that was received in relation to the criteria that we established, we recommend that the bid be awarded to **Global Lease Group, Inc.** pending successful approval by the Whatcom County Council.

The following is a breakdown of what Global Lease Group can provide and how that meets our selection criteria:

Global Lease Group appears to successfully meet the criteria in regards to financial resources, experience in fleet leasing, organization and equipment. Global Lease Group provided relevant references to verify their ability to perform the work required. Global Lease Group supplied a yearly mileage of 20,000 per vehicle with additional mileage charged at \$.49 per mile. Global Lease Group has met the criteria for type of vehicles, warranty coverage.

The following is a price breakdown on the lease offer form Global Lease Group (depending on the combination of vehicles that are selected to lease):

- The lowest combined lease cost (based on the four cheapest vehicles) per month is \$3,762.94 (tax included)
- Lease cost per year for the four cheapest vehicles is \$33,866.43 (tax included)
- Lease cost for the four cheapest vehicles over the 36 month lease is \$101,599.29 (tax included)
- The highest combined lease cost (based on the four most expensive vehicles) per month is \$6.497.52 (tax included)

- Lease cost per year for the four most expensive vehicles is \$58,477.82 (tax included)
- Lease cost for the four most expensive vehicles over the 36 month lease is \$233,911.30 (tax included)

As there are no other bidders for this lease, the Sheriff's Office recommends the bid be awarded to Global Lease Group, Inc. The four vehicles that we would like are:

2023 Ford F-150 4X4 STXC Crew Cab 2023 Nissan Titan 4X4 SV Crew Cab 2023 Nissan Pathfinder AWD SV SUV 2023 Nissan Rogue AWD SV SUV

The total cost for this 36 month lease is: \$195,423.55
