2025 SESSION OVERVIEW

Budgets

- Operating \$77.8 billion biennial expenditures
 - \$25 million savings from Gov. Ferguson vetoes
 - 8.2% increase \$4.4 billion new revenue
- Capital -\$7.6 billion biennial expenditures
 - Average local community project was \$578,000
- Transportation \$15.5 billion biennial expenditures
 - \$3.2 billion in new revenue over 6 years

Bills

I,903 introduced; 422 passed; I vetoed –
 22% passage rate

2025 SESSION WHATCOM COUNTY

- Nooksack Adjudication
 - \$200,000 of \$600,000 request for technical assistance (operating budget)
 - \$1.25 million for county facility needs. \$2.8 requested. (capital budget)
 - \$0 for Superior Court needs
- Lummi Ferry funding reappropriated. No new funding
- \$4 million for the Swift Creek settlement decree (capital budget). \$11.6 requested
- \$10 million for phase 4 of the Nooksack River floodplain project

- \$1.17 million for the county alternative response team
- \$11.5 million for county 23-hour crisis relief center was reappropriated (capital budget)
- \$15 million in operating budget for grants to 23-hour crisis relief centers, but not including Whatcom County
- Recovery navigator program reduced by 20%
- Public health funding reduced by at least \$24 million
- No proviso for north sound assessment of youth cooccurring treatment needs



2026 SESSION WHAT TO EXPECT

- 9 legislative elections
 - Won't impact majorities; will impact tenor
- 60 days starting Monday, Jan. 12
- Bills introduced in 2025 but not passed are eligible in 2026

- Operating budget problems
 - \$900 million less than June forecast
 - Next revenue forecast is Nov. 18
- Governor's proposed supplemental
 - Early/mid December


- Recommend prioritizing items that only Whatcom County will champion
