Recognized opportunity to improve

- Increase thresholds
- Purchasing code complete revision within 6-12 months
- Procurement manual
- Standardized contract formats / templates
- Internal training for each Department



Proposal for discussion (AB2025-264)

Proposed changes (current):

• Increase the threshold for contracts that require council approval to \$250,000. ORD on Council agenda for introduction.

• Opportunity to revisit when considering complete revision in 6-12 months.

- Add a quarterly reporting requirement on all contracts issued in the previous quarter
- Enhance public contract search database (administrative change)



Potential Benefits of Proposed Changes

Increase the efficiency in executing contracts to delivering services

- Raising the threshold to \$250,000 allows for ~65% of contracts to be executed more efficiently while retaining approval authority by the Council on 88% of the awarded funds.
- Reduces the staff time associated with preparing for council approval of contracts:
 - Based on 2024 contract numbers, we estimate this would free up staff hours equivalent to 30-60% of 1.0 FTE .
- Provides more time in committee to focus on other items, including budget decisions that are necessary before a contract can be executed.
