**ACTION TAKEN**

The Whatcom County Council adopted the following at its July 26, 2022 meeting: **ORDINANCE (2022-054) AMENDING THE 2022 WHATCOM COUNTY BUDGET, REQUEST NO. 10, IN THE AMOUNT OF \$3,835,565 (AB2022-387)** This ordinance amends the 2022 Whatcom County Budget as follows: From the General Fund: Appropriate \$257,181 in Health to fund Youth Cannabis and Tobacco Prevention programs from grant proceeds; appropriate \$85,563 in Sheriff to fund Axon body worn cameras and interview room cameras software maintenance agreement; appropriate \$2,500 in Sheriff to fund increase in Recreational Boating Safety program from grant proceeds; appropriate \$48,476 in Non-Departmental to fund What-Comm E911 Ops program from pass-through grant proceeds. From the Road Fund, appropriate \$2,000,000 in Maintenance & Operations to fund emergency flood work associated with Nov-Dec 2021 weather events. From the Whatcom County Jail Fund: appropriate \$12,000 to fund livescan fingerprint machine replacements; appropriate \$7,000 to fund Forest Service work crew truck transmission rebuild from grant; appropriate \$1,200,000 to fund jail beds in Snohomish County. From the Behavioral Health Program Fund, appropriate \$98,269 to fund two full-time employees for the Whatcom Co-Responder program from grant proceeds and record labor pool adjustments. From the Equipment Rental and Revolving Fund, appropriate \$93,676 to fund medical van uplift. From the Administrative Services Fund, appropriate \$30,900 in Facilities to fund miscellaneous additional expenditures. Ordinance introduced July 12, 2022. **RESOLUTION (2022-034) AMENDING THE 2022 FLOOD CONTROL ZONE DISTRICT & SUBZONES 2022 BUDGET, REQUEST NO. 4 (COUNCIL ACTING AS THE WHATCOM COUNTY FLOOD CONTROL ZONE DISTRICT BOARD OF SUPERVISORS) (AB2022-388)** This resolution amends Exhibit B - Flood Capital Program to include \$5,922,000 previously approved in 2022 supplemental budget requests for six capital projects. Resolution introduced July 12, 2022. **ORDINANCE (2022-055) PROVIDING FOR SUBMISSION TO THE QUALIFIED VOTERS OF WHATCOM COUNTY A PROPOSITION RENEWING THE LEVY OF A REGULAR PROPERTY TAX AT A RATE OF \$0.295 OR LESS PER \$1000 ASSESSED VALUATION TO CONTINUE TO PROVIDE EMERGENCY MEDICAL SERVICES (AB2022-382)** This ordinance submits to the Whatcom County Auditor, for inclusion on the November 8, 2022 general election, a proposition renewing the levy of a regular property tax of \$0.295 or less per thousand dollars of assessed valuation for each of the six consecutive years, with collection beginning in 2023, for the continued provision of emergency medical services. Ordinance introduced July 26, 2022.

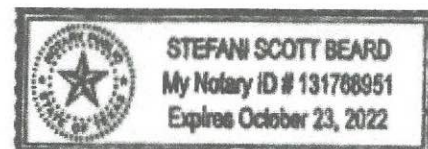
