Requested Action

Facilities Management respectfully requests that the County Council approve this recommendation and authorize the County Executive to sign the Approval for Contract Award to Faber Construction Corporation for the installation of a new modular office building at the Point Roberts Transfer Station. Upon receipt of the signed Approval for Contract Award form, Facilities will submit the construction contract to the County Executive for execution.

Background and Purpose

Bid proposals for this project were opened at 2:30 PM on Tuesday, November 14, 2023. One (1) responsive and responsible bid was received from Faber Construction in the amount of \$228,060.00, including supply, delivery, installation, and applicable Washington State sales tax.

Funding Amount and Source

The total funding for this capital project is \$235,000.00, as budgeted in the Solid Waste Fund

Funding for for the purchase, delivery, and installation of this building, in the amount of \$150,000.00, was originally approved by Council on Supplemental ID #2023-3877, approved on Supplemental #3, Ordinance #2023-007. Additional funding in the amount of \$35,000.00 was approved by Council on Supplemental ID #2023-3988, approved on Supplemental #9, Ordinance #2023-037. The balance of funding in the amount of \$50,000.00 was approved by the Executive's Office on November 20, 2023, via a budget transfer from the current Solid Waste budget.
