The Whatcom County Council will consider adopting and may amend the following at its 1 p.m. meeting on August 16, 2021, or at a later date: ORDINANCE REPEALING OR-DINANCE 2021-029, WHICH IMPOSED AN INTERIM MORA-TORIUM ON THE ACCEPTANCE AND PROCESSING OF APPLICA-AND PROCESSING OF APPLICATIONS FOR NEW OR EXPANDED FACILITIES IN THE CHERRY POINT URBAN GROWTH AREA, THE PRIMARY PURPOSE OF WHICH WOULD BE THE SHIPMENT OF UNREFINED FOSSILFUELS NOT TO BE PROCESSED AT CHERRY POINT (AB2021-475) This ordinance will repeal Ordinance 2021-029 (adopted May 18 2021) which imposed an interim 18, 2021) which imposed an interim moratorium on the acceptance and processing of applications for new or expanded facilities in the Cherry Point Urban Growth Area, the primary purpose of which would be the shipment of unrefined fossil fuels not to be processed at Cherry Point. Introduced August 2, 2021.


