### Budget Narrative

Criminal Justice Treatment Account (CJTA) funds will be allocated to Whatcom County programs per the budget overview above. Funds will be used for the selected service areas in the following manner:

- **Contract Administration:** Whatcom County retains CJTA funds at the rate of 10% of total expenditures to support contract oversight and administration.
- **Jail MOUD:** Medications for Opioid Use Disorder and other medication-assisted treatment options are provided by health staff in the jail as indicated in support of recovery for CJTA participants.
- **Jail and Out-of-Custody SUD Assessments & Care Coordination:** Services are contracted through community treatment provider Lifeline Connections, providing jail-based/community-based assessments and coordination of rapid release to



community treatment programs in accordance with judicial orders. Care coordination in jail and in community comprises the majority of contract activities, facilitating less-restrictive treatment options for CJTA participants. Max of 26% can be spent on in-custody support.

- **Residential Treatment:** The CJTA Panel elected to set aside 3% of CJTA funding as a fund to cover the cost of treatment for CJTA-eligible individuals that is not billable to their Medicaid or other insurance. Community treatment providers who demonstrate a cost burden or gap in coverage for a CJTA participant's treatment will can request funds in the amount of the gap in coverage.
- **Recovery Court Case Management:** 34% of Whatcom County CJTA funds are designated to Recovery Court for the provision of intensive recovery-based case management, including coordination and referrals for community services, such as treatment and rental assistance. Recovery Court Case Management is funded exclusively by CJTA Supplemental funding.
- **Rental Assistance:** Services are contracted through the Opportunity Council, who disburses up to 6 months of rental subsidy to CJTA participants in recovery housing, with the possibility of approved 6-month extension. Referrals are provided by the Recovery Court Case Manager and other community partners, with priority for subsidy placed on therapeutic court participants. Rental Assistance is provided with base and supplemental funding.
