The Whatcom County Council adopted the following at its June 18, 2019, meeting:

ORDINANCE (2019-047) REGARDING THE SUSPENSION OF WHATCOM COUNTY CODE 1.28 TO UPDATE THE CORRECTIONAL FACILITIES OPERATIONAL STANDARDS

AB2019-308

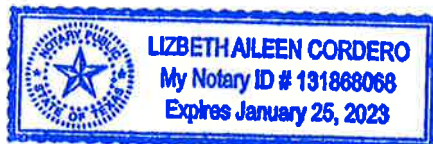
