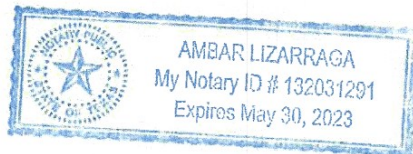
COUNCIL ACTION TAKEN

The Whatcom County Council adopted the following at its April 3, 2020, meeting: EMERGENCY ORDINANCE (2020-015) AUTHORIZING AN INTERFUND LOAN TO FINANCE CASH FLOW COVID-19 EMERGENCY RESPONSE (AB2020-165): This ordinance authorizes the Whatcom County Treasurer to make an interfund loan from the Public Utilities Improvement Fund to the COVID-19 Emergency Response Fund for cash flow purposes. The Loan shall not exceed \$1,000,000 and shall be for a term not exceeding eighteen months. One-half percent interest shall be charged on the loan. This ordinance was introduced April 3, 2020. EMERGENCY ORDINANCE (2020-016) ESTABLISHING THE COVID-19 EMERGENCY RESPONSE FUND AND ESTABLISHING A BUDGET FOR THE COVID-19 EMERGENCY RESPONSE FUND (AB2020-166): This ordinance authorizes a new special revenue fund be established titled the "COVID-19 Emergency Response Fund", the fund is approved with an initial budget of \$1,750,000. This ordinance was introduced April 3, 2020.
