

Enclosed are two (2) originals of an amendment to the contract between Whatcom County and DentAll, PLLC for your review and signature.

Background and Purpose

Dr. Jessica Dubek of DentALL, PLLC, was chosen from the RFP process in 2023 to provide dental services for inmates at the Whatcom County Jail and Work Center. It became apparent quite quickly that more hours were needed due to the number of inmates needing dental care. This Amendment will add more hours to the contract.

Funding Amount and Source

Funding for this contract comes from the Corrections Bureau budget and the maximum annual compensation will not exceed \$171,600.00.

Differences from Previous Contract

This Amendment adds \$55,600 to the annual compensation and adds 185.5 hours for a total of 452 hours for the year.
