THIS AMENDMENT is to the Contract between Whatcom County and DentAll, PLLC, dated May 31, 2023 and designated "Whatcom County Contract No. 202306005". In consideration of the mutual benefits to be derived, the parties agree to the following:

This Amendment increases the maximum annual consideration by \$55,600.00 to a total annual consideration of \$171,600.00. This will increase the number of hours worked from 266.5 to 452.00.

Unless specifically amended by this agreement, all other terms and conditions of the original contract and any previous Amendments shall remain in full force and effect.


This Amendment takes effect: September 1, 2024, regardless of the date of signature, and expires December 31, 2024.

Enclosed are two (2) originals of an amendment to the contract between Whatcom County and DentAll, PLLC for your review and signature.

▪ **Background and Purpose**

Dr. Jessica Dubek of DentALL, PLLC, was chosen from the RFP process in 2023 to provide dental services for inmates at the Whatcom County Jail and Work Center. It became apparent quite quickly that more hours were needed due to the number of inmates needing dental care. This Amendment will add more hours to the contract.

▪ **Funding Amount and Source**

Funding for this contract comes from the Corrections Bureau budget and the maximum annual compensation will not exceed \$171,600.00.

▪ **Differences from Previous Contract**

This Amendment adds \$55,600 to the annual compensation and adds 185.5 hours for a total of 452 hours for the year.
