ORDINANCE GRANTING CASCADE NATURAL GAS CORPORATION A NON-EXCLUSIVE FRANCHISE TO OPERATE AND MAINTAIN A NATURAL GAS PIPELINE SYSTEM WITHIN WHATCOM COUNTY. (AB2021-414):

This ordinance grants non-exclusive twenty-five (25) year franchise to construct, operate, maintain, remove, replace and repair new or existing pipeline facilities, together with equipment and appurtenances thereto, for the transportation of natural gas within and through Whatcom County, Washington. Council introduced the above at its September 14, 2021 meeting.

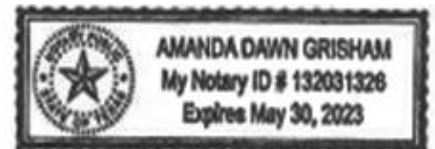
