LIST OF PETITIONS FOR PROPERTY TAX REFUNDS

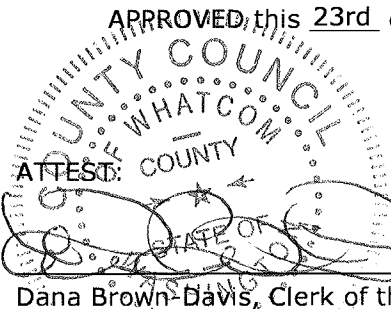
WHEREAS, RCW 84.69.020 requires the County Treasurer present a list of all petitions for property tax refunds made during the previous year to the County Council, and;
