I am an expert in the behavioral health system across the continuum of services, including outpatient and prevention. I have a long history of working with the Managed Care Organizations who fund the Medicaid-funded behavioral health services in our region as well as working with the Health Care Authority, Office of Insurance Commissioner, and Department of Health at a state level. I have also been a clinician historically, working with the unhoused population in King County where I specialized in the population of clients with the most extreme and acute co-occurring issues. Please describe why you're interested in serving on this Advisory Group. | I believe, and statistics show, that the criminal justice system has become a space where those with behavioral health issues often get directed due to the lack of other resources for behavioral health and social determinants of health. It seems that Whatcom is putting a lot of effort into redesigning the criminal justice system to try to meet the needs of this population. Additionally, I think that often those who have a history of managing/participating/working in the behavioral health system sit on more programmatic-specific boards. I have an interest in sitting on the Finance Advisory Board specifically given my knowledge of how the behavioral health system is funded in Washington and with the asknowledgement that work is essential to provide sustainability over time. |
